Despite a focus on restoration of salmon and other anadromous fish, which together constitute the *de facto* totemic species of the region, efforts in behalf of salmon no longer focus exclusively on fish production, but have matured into a concern for habitat at the watershed level. For this and other reasons, restorationists in the Northwest are now working on a wide array of habitats, from coastal wetlands to forests, prairies and arid scrublands far inland.
